ORDER GRANTING DEBTORS' MOTION FOR VALIDATION AND APPROVAL OF THE UNCOMPENSATED CARE REIMBURSEMENT LIABILITY

TO THE HONORABLE BRENDA T. RHOADES, UNITED STATES BANKRUPTCY JUDGE:

Having considered the *Debtor's Motion for Validation and Approval of The Uncompensated Care Reimbursement Liability* [Dkt. No. 40] (the "Motion"), which was filed on July 10, 2018, the Court finds that: (a) jurisdiction over the matters in the Motion is proper pursuant to 28 U.S.C. §§ 1334, 157; (b) venue is proper in this Court pursuant to 28 U.S.C. §§ 1408 and 1409; (c) proper and adequate notice of the Motion has been provided and no further notice is needed; (d) the relief sought in the Motion is in the best interests of the Debtor, its creditors, and all parties-in-interest; and (e) good and sufficient cause exists for granting the relief requested in the Motion. Accordingly, it is hereby ordered that:

- 1. The Notice of Overpayment and the resulting Uncompensated Care Reimbursement Liability in the amount of \$204,022.66 (the "<u>Uncompensated Care Reimbursement Amount</u>") is validated and approved. ²
- 2. The Uncompensated Care Reimbursement Amount is hereby deemed legally binding, incontestable liabilities of the District, and the District may issue Bonds in a principal amount sufficient to satisfy the Uncompensated Care Reimbursement Obligation of \$204,022.66 plus an amount necessary
