ORDER GRANTING DEBTORS' MOTION FOR VALIDATION AND APPROVAL OF SETTLEMENT AGREEMENT BETWEEN THE DEBTOR AND THE OFFICE OF INSPECTOR GENERAL

TO THE HONORABLE BRENDA T. RHOADES, UNITED STATES BANKRUPTCY JUDGE:

Having considered the *Debtor's Motion for Validation and Approval of Settlement Agreement Between the Debtor and the Office of Inspector General* [Dkt. No. 39] (the "<u>Motion</u>"), which was filed on July 10, 2018, the Court finds that: (a) jurisdiction over the matters in the Motion is proper pursuant to 28 U.S.C. §§ 1334, 157; (b) venue is proper in this Court pursuant to 28 U.S.C. §§ 1408 and 1409; (c) proper and adequate notice of the Motion has been provided and no further notice is needed; (d) the relief sought in the Motion is in the best interests of the Debtor, its creditors, and all parties-in-interest; and (e) good and sufficient cause exists for granting the relief requested in the Motion. Accordingly, it is hereby ordered that:

1. The Settlement Agreement in the amount of \$1,320,000 (the "<u>OIG Settlement Amount</u>") is validated and approved.

2. The OIG Settlement Amount is hereby deemed legally binding, incontestable liabilities of the District, and the District may issue Bonds in a principal amount sufficient to satisfy the OIG

Obligation of \$1,320,000 plus an amount necessary to pay costs of issuance related to such Bonds, that meet the requirements of the parameters established in the Judgment.²
